Sterling Subsurface Sewage disposal Regulations: Reg. IV k. 2. – Area Subject to Vehicular Traffic. Neither the primary leaching area nor the reserve leaching area may be located under an area subject to vehicular traffic. Areas subject to vehicular traffic include, but are not limited to, driveways, parking lots and loading docks.
