Wood Funds	It was brought to the Select board's attention that there are two "wood funds" that were bequeathed to the Town in the 1800s. These funds can only be expended to assist women in need and the money must be used for firewood. A woman in need has asked the board to consider dispensation of some of the funds to buy wood pellets to heat her home this winter. The Board is very receptive to this idea. The Executive Assistant will ask the recipient to advise the Board as to how much tonnage she needs to heat her home for the entire winter. As per the stipulations of the Jacob Conant Wood Fund, a Justice

	of the Peace and a Deacon will be asked to attend the next meeting in order to join the Select board in voting on the decision to buy the wood pellets.
1835 Town Hall discussion	 Joe Booth, the Project Designer Manager for the 1835 Town Hall roof project attended the meeting. Robert Barwise and Jack Chandler of the 1835 Town Hall Committee also attended. At present, all roof work has desisted due to unanticipated structural problems that make the roof unsafe. On September 13th a conference call took place between Mr. Booth, the 1835 members, Contractor Mike Vareika, Project Manager Barry Brown, Engineer Mike Rongione and BOS Chairman Rich Lane. During that call they focused on resolving the unforeseen structural issues and getting the roof finished, while staying within available funds. The following was decided; The 1835 Committee authorized up to \$11,000.00 for additional designs that are required to establish exact construction costs for major repairs to the timber bays LVL sandwiching will be used, as it is the most economically sound choice and Joe Booth stated that once complete, the building will be strong enough to endure another 100 years. The "end work" will be removed from the existing contract (Interior finish, wall boarding, painting, electrical, etc.) in order to get the roof repaired and replaced while staying within the confines of the available funds. Once the structural repairs are completed and the roof is replaced, the Committee will use some of the funds from the Massachusetts Cultural Facilities Fund grant to finish SOME of the original "end work" that had to be removed from the original contract. In so doing, the 1835 Town Hall Committee is aware that they will end up with less money to enhance the Great Hall. However, they are hopeful that they will be able to secure future grants to assist with the final enhancements. The Committee will work closely with Mr. Booth and Town Administrator, Ross Perry to manage the contract adjustments, control the budget and keep the project moving forward.
	 <u>Town Administrator Report 9-19-18</u> Nuisance Property Update: 3 Princeton Rd. The BOH Agent has talked with the new owner and reports: Three dumpsters of building materials were removed. He continues to work on removing the rest of the contents as time permits A pest control company continues to service the site twice a month. No new pest issues reported. The front lawn is mowed periodically. The message has been delivered that both the BOH and BOS are interested that progress continue. Follow up will continue.
