Minutes

After discussion Selectman Cranson moved to approve the public minutes for the November 16th, 2018 meeting, as written. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

ZBA Appointment

After discussion, Selectman Cranson moved to appoint Charles Conroy to the position of Alternate Member to the Zoning Board of Appeals. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried. The term of office will expire on June 30th 2021.

Cultural Council Appointments After discussion, Selectman Cranson moved to appoint Beth Stephenson to the Cultural Council. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried. The term of office will expire on December 5, 2021.

Reconfirm curb cut votes

As an administrative procedure, the Selectman Kilcoyne moved to reconfirm the votes that were taken on November 16th to approve the curb cuts for Lot #2 and #3 on Justice Hill Road. Selectman Cranson 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

SLCT Contract

Robert Kadles, President of the SLCT and Chris Detsikas, Executive Director came before the Board to agree upon the terms of the proposed SLCT Contract. During discussion the Board members pointed out the following discrepancies:

- In Section 2, under terms, it states that the agreement shall be for 5 years. The current proposed agreement is a ten year agreement. Mr. Kadles will make the correction.
- Under Section 3 (O), the document contains the term "Town Manager" instead of Town Administrator. Mr. Kadles will make the correction.
- Mr. Kadles will also change the start date of the agreement to Jan. 1, 2019 Dec. 31, 2029 so
 that it coincides with the Comcast agreement that will go before the Board on December 12th.
- The requirement of a monthly report for the first year (which was on the ORIGINAL agreement) has been deleted from this agreement since the SLCT has been operating for 10 years

After further discussion, Selectman Cranson moved to approve the contract with the recommended changes. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

The Board will send letters to State and Federal Representatives to support the continued PEG funding for local cable operations. Chris Detsikas will help craft the letter.

Broadcast policy for SLCT

The Board thanked the SLCT management and crews for their dedication and for the work they do to keep the public apprised of what is happening in Town government, as well as advertising and filming local events. After discussion, Selectman Cranson moved that, the Town Administrator craft a letter to the SLCT requesting in writing that they record and broadcast Board and Committee meetings with the selection of which meetings to record to follow a priority list or by special request from the BOS. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

Action on Unacceptable behavior The Board of Selectmen have received a letter and several verbal complaints regarding unacceptable behavior that took place prior to the Planning Board meeting on November 28th, 2018. According to witnesses and complainants, a Planning Board member verbally accosted an SLCT camera operator as well as a resident. Although the Board of Selectmen acknowledges that they have no purview over the other elected boards, the BOS emphatically disagrees with such conduct and publicly offered an apology to the victims and to the public who witnessed the attack. After discussion, Selectman Kilcoyne moved that the Town Administrator draft a letter to all Boards and committees to remind everyone that;

- Inappropriate behavior has no place in the governing body of the Town of Sterling... whether by board/committee volunteers or from the public.
- Rules of decorum and respect should be adhered to and improper conduct will not be tolerated
- The services of the SLCT are very beneficial in keeping the public appraised of the functions of Boards and Committees. Therefore, their involvement should be encouraged.
- The Open Meeting Law permits ALL public meetings to be recorded.

Selectman Cranson 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

Chris Detsikas stated that the SLCT volunteers will be directed to don their identification badges when filming. SLCT will also take measures to give prior notice when they intend to record a meeting.

Christmas schedule

Selectman Cranson moved that the Municipal Building be closed on December 24th, 2018. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried. At the next meeting, the Board will discuss if time will be billed to the employees.

- Downtown revitalization, (Sidewalks, Common, Parking)
- Beach project
- Revitalization and acquisition of recreational fields
- Resurfacing of recreational courts
- Support for PEG funding to continue local programming

TA Report

Openings:

Gerry Kokernak recently announced his retirement from the Finance Committee and Capital Investment Committee. He has served on both of these committees for five years. Gerry has been a significant contributor to these committees and to the Town. I have huge respect for his valuable input. There are now openings on these committees. With the Board's OK, we will post the Finance Committee position. The appointment will be by vote of the Finance Committee, Moderator and Selectmen.

Adjourn

The Board publically thanked Mr. Kokernak for playing such a large and important role on both the Finance and Capital Committees. He will be missed.

Facilities:

The door lock cores were changed a month ago as previously mentioned. However, we discovered the electric door lock doesn't work as expected. It was installed ~3 years ago to open and relock when a key fob was used. But now we have different requirement that involves two hold open periods. One during the normal work day and one for evening meetings. This additional function can be completed for \$1,222.64. If OK with the Board, I propose moving ahead and funding this via the Facilities expense budget. Selectman Cranson moved to approve the disbursement of \$1222.64 for the purpose of updating the key fob system to allow for duel "hold open" periods. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.

There are currently 3 doors without the electric open and relock capability. Equipping these doors for the upgraded electric locking functionality will cost \$9,552.09. This could be funded from the facilities expense account, which may require a reserve fund transfer later in the budget year, or held for a separate FY 20 budget request. The consensus of the Board was to hold this request for Town Meeting.

Economic Development:

As Sterling moves ahead in economic development and creating the image a vibrant town, what about creating a web camera view of the town common, accessed from the Town Web site? The proposed camera would be mounted on the Butterick building. I have a not to exceed cost of \$2500. If the Board agrees, the EDC and I will look for local businesses to sponsor this web page. Selectman Cranson moved to have the EDC solicit sponsorship for the Webcam. Selectman Kilcoyne 2nd. Selectman Cranson – Aye. Selectman Kilcoyne – Aye. Chairman Lane – Aye. Motion carried.
