Complete Streets Policy	The Town Planner has requested that the Board approve the Complete Streets Policy. The approval and adoption of the Policy Statement is procedural – once approved by MassDOT, Sterling is eligible for up to \$50,000.00 to complete the Tier 2 Prioritization Plan. This statement solidifies the Town's commitment to create a safe transportation network for residents of all ages and abilities. It allows the Town to become eligible for additional funding at the state level for infrastructure, planning and implementation of the Complete Streets goals. The agreement will allow up to 15 inspections per year and it will not impact either town, financially.
