MEETING:

Vice Chairman Cranson called the Select Board meeting to order at 6:09 pm. Roll Call: Selectman Cranson – Present. Selectwoman Sonnenberg – Participated remotely. Chairman Kilcoyne – arrived at 6:11.

Removal of warrant articles

The ATM will be held at the Sterling Airport on June 22, 2020. The purpose of this meeting is to streamline the warrant. The concern of the Board is that drawn out discussions are not particularly suitable for the airport venue. Therefore, after discussion Selectman Cranson moved to remove the following articles from the warrant;

Article 28 – Amendment to Protective Bylaw – Earth Removal

Article 29 – Amendments to Protective Bylaw – Earth Removal

Article 30 - Amendment to Protective Bylaw - Groundwater Protection District

Article 31 - Amendment to Protective Bylaw - Signs

Article 32 – Amendment to Protective Bylaw related to Town Center and Commercial

The citizen petitioners for Article 33 – Amendment to Protective Bylaw related to site Plan Review and Article 40 – Playground structure at Houghton School have agreed to withdraw their petitions at this time, with the understanding that they will be included, without further requirements, on the next Town Meeting. Therefore, Selectman Cranson moved to remove Articles 33 & 40 from this warrant. Selectwoman Sonnenberg – 2^{nd} . Selectman Cranson – Aye. Selectwoman Sonnenberg – Aye. Chairman Kilcoyne – Aye. Motion carried.

Outdoor venues for alcohol

As a concession to the restrictions, resulting from COVID-19, the State Alcohol Board has granted authority to the Select Board to approve outdoor seating for alcohol. This change to the license will be valid until Nov. 1 2020. The BOH agent, David Favreau reports that the Board of Health has no issue with this as long as the business adheres to food code requirements. After discussion, Selectman Cranson moved that the Select Board will consider requests for outdoor service of alcohol. Selectwoman Sonnenberg – 2^{nd} . Selectman Cranson – Aye. Agreement/Hold harmless
