PUBLIC HEARING	Town of Sterling PUBLIC HEARING NOTICE Alcohol License - Davis Farmland LLC, 145 Redstone Hill Road April 29, 2020 Butterick Building, 1 Park Street, Room 205, 6:35 pm, The Sterling Board of Selectmen will conduct a Public Hearing re: the issuance of an All Alcohol License to Davis Farmland.           Selectman Cranson announced that she will recuse herself from voting in this matter because she is currently employed by Davis Farmland.           Attorney Finklestein and Larry Davis participated remotely and reported to the Board that the Davis Farmland is seeking an annual All Alcohol License which is a change from their current license for beer and wine only.           They are also filing to alter the premises. They wish to enlarge the Herd Rock Café by adding a 1,222 sq. ft. addition that includes both indoor and outdoor seating. This will add an additional room, 3 entrances and egresses, plus 2 additional lavatories. The new total capacity for that building will be 220.           Specifics; <ul> <li>The manager of the Davis Farmland is Laurence Davis. He will be the manager of record for the All Alcohol license.</li> <li>The Farmland is comprised of 13.7 acres of fenced in area.</li> <li>There will be three points of service, the Herd Rock Café , the Udder Herd Rock Café and the slushy shack.</li> <li>Any and all employees who have anything to do with the serving of alcohol will be T.I.P.S. certified.</li> <li>No alcohol will be allowed in areas that prohibit food and drink. However, guests will be allowed to carry their alcoholic beverage throughout the park.</li> <li>Security measures, within the Farm area, include wrist bands that have pull tabs which allow a 4 drink maximum per guest and specific colored glasses that distinguish alcohol from non- alcoholic beverages.</li> <li>The Farmland</li></ul>

	<ul> <li>Hours - 11:00 am – 9:00pm on Sundays through Thursdays and 11:00 am – 10:00pm on Friday and Saturday</li> <li>The point of sales are the Herd Rock Café, the Udder Herd Rock Café and the Slushy shack</li> <li>Alcohol must be consumed within the confines of the farm's fenced perimeter</li> <li>The Board supports the alteration of premise.</li> <li>Selectwoman Sonnenberg 2<sup>nd</sup>. Street Light Twine Road Wekepeke	Jennifer Luksha requested that the Board consider placing a street light at the dead end of Twine road. She reported that it is dangerous at night, since people are sometimes taken unaware that the road is barricaded. She also said that the area is occasionally used for mischief. Chief Chamberland dispatched an officer who confirmed that the end of Twine Road is unlit. After discussion, Selectman Cranson moved to request that Sterling Municipal Light install a streetlight at the dead end of Twine Road. Selectwoman Sonnenberg 2 <sup>nd</sup> . Discussion	<ul> <li>The Chronology of the Wekepeke water source follows; <ul> <li>1882 Legislatures Act Authorizes the conveyance of the waters of the Wekepeke Brook, in Sterling, to Clinton</li> <li>7/23/2007 Letter to Regional Assessor to Town Administrator questioning the PILOT calculation as paid by Clinton</li> <li>2/23/2007 Sterling Select Board send letter to Clinton Select Board with concerns about the condition of the 3 dams in Sterling, owned by Clinton – asking to schedule meeting to discuss repairs</li> <li>10/25/2012 Sterling Select Board send letter to Clinton Select Board inviting them to meet to discuss a plan to manage the Wekepeke water systems</li> <li>2013/8/13 Sterling has a proposed warrant article to petition State Legislature to impose restrictions to the Wekepeke watershed. In reaction, Clinton Select board votes to stop PILOT payments to Sterling. According to the Clinton Town Solicitor, the PILOT was a voluntary payment</li> <li>2020 /3/4 Sterling records indicate that PILOT payments from Sterling stopped in 2013</li> <li>Invoices from 2013-2017 were not paid</li> <li>Sterling stopped invoicing Clinton in 2018</li> <li>2020/4/23 Sterling Select Board sent letter to Clinton Select Board requesting a joint meeting to discuss the future use of the Wekepeke land, dam repair/removal and timely notification to Sterling BOS and residents prior to changes to the land (i.e. forestry, dam removal, etc)</li> </ul> </li> <li>There will be a round-table discussion in the future to discuss concerns and what the Town would like to see happen with the Wekepeke water and surrounding land.</li> <li>The Board discussed the following warrant articles. 	Budgets:
Business and Correspondence	<ul> <li>We continue to monitor cash flow. Fred and Vicki have extended the analysis out to the end of Sept and the Town still has sufficient cash flow, even with very conservative revenue forecasts.</li> <li>The revised FY 21 Omnibus budget is looking close to total of \$24,420,482, with a Property tax levy of \$20,496,277 with an overall increase of 2.58%; resulting in an average tax bill increase of \$266 or about 4.27%, before using any of the Stabilization fund to further reduce the tax rate. This is down from ~6.5% increase discussed at the last Fin Com meeting. There are still some changes that we are working on. So, this budget isn't final.</li> </ul>
	<ul> <li>The expense warrant the Board will sign tonight is for \$424,913. As much as the warrants change, this one is down by about \$326,000 from the \$750K average. This shows the Dept. Heads are doing their best to reduce expenses for the rest of this budget year. Thank you to all for their work.</li> </ul>

The speakers asked that this be part of Select Board meeting as these tend to draw more attendees /viewers than a standalone meeting. 	• At a previous meeting the Board voted to appoint interim members to the Planning Board and Board of Health, to serve 'until the May elections'. Since <u>elected</u> members serve until the next election when their term expires; the <u>same applies to interim</u> appointments, including when the elections occur in June or later. The Town Clerk and I agree, this means the new PB and BoH members can continue to serve (and vote) through June or beyond if elections are pushed
	out again.
