After review of the area in question with Mr. Grady, Mr. Mosely moved to issue a negative determination as it is not wetland. Mr. Pineo seconded and the commission vote unanimously.

8:00 P.M. : Pursuant to MGL ch 131 s 40 as amended there will be a public meeting on a request for a determination by Felicio Lana of 7 Sherwood Street to determine if Cutting of trees and grading and looming on the buffer zone at 7 Sherwood Drive is subject to the Act.
