Public Hearing:

7:45 PM: Pursuant to MGL ch 131 s 40 as amended there will be a public hearing on a Notice of Intent by James Chacharone for grading, parking and storm-water within the buffer zone to accommodate a 26000 square foot professional office building out of the buffer zone at 92-102 Leominster Road and 49 Laurel Wood Road. The hearing will be held in the Butterick Municipal Building 1 Park Street Room 207 at 7:45 PM on Tuesday September 19, 2017. The public is invited to attend. Anyone wishing to view plans may call the commission office Monday through Friday from 8 to 4 PM for an appointment or they mail email for a PDF copy at mmarro@sterling-ma.gov

Glenn Krevosky and Brian Milisci represented the applicant. He outlined the history of the lot and the resource area delineation that classified the stream on the property as intermittent. He outlined that the stream has potential as a trout fishery. He noted the work comes no closer than 50 feet. He did outline that the storm water report is in conformance with a discharge to a fishery despite the fact the stream has not yet been declared. The Commission is going to examine the issue and work with the commonwealth and Mr. Krevosky. MM noted that he examined the storm water issue and agrees that it is not an issue. Brian Milisci explained the set up of the building and parking into account. He also explained the reasons for the renewed permitting. Mr Pavlowich examined the storm water basin and it's potential effectiveness. Mr. Milisci explained the future building and noted that if that was executed, the
