7:40 PM In accordance with MGL ch 131 s 40 as amended, there will be a public meeting on a request for a Determination at 114 Pratts Junction Road by Joe Day. This project consists of a 7,200 square foot metal building with approximately 16,000 square feet of impervious access drive/parking area. All of the site stormwater run-off shall be detained and re-charged on-site. A Stormwater permit from the Conservation Commission is required in accordance with the Sterling regulations.

Paul Grasewicz appeared on behalf of the applicant and explained how the proposal complied with the stormwater by law. Mr, Michalak reviewed the stormwater calculations and expressed satisfaction. He moved tom issue a negative determination and a standard stormwater permit. Mr Pineo seconded and the commission voted unanimously.

The meeting adjourned at 8:25 PM by a unanimous vote on a motion by Mr. Michalak that was seconded by Mr. Pineo
