7:40 PM In accordance with MGL ch 131 s 40 as amended, there will be a public meeting on a request for a Determination at 20 Pratts Junction for the demolition of a single family home with a reconstruction of 2 commercial buildings to sever contractor operations. As the total alteration is 68,000 square feet, this will also be a combined public meeting for a local storm water permit. The applicant is Tshay LLC.

James Tetrault represented the applicant. He oriented the commission to the project and the stormwater remediation proposed and its method of compliance with the local by-law. Mr. Marro examined the site and recommended a negative determination for the demolition and the approval of a stormwater permit under local by law. Mr. Michalak reviewed the storm water hardware on the plan and compared with the routing chart in the storm water supporting calculations.
