### MINUTES

STERLING CONSERVATION COMMISSION

4.1 Orchardist proposal for Waushacum Meadow- Ray Faucher, Orchardist, appeared before the commission to speak to the commission concerning the existing apple orchard. He outlined the site walk he went on accompanied by Mr. Marro. He noted that he will not cut any dying trees down as it is not a part of the proposal. He is not looking to prune the orchard for a healthy state and not production. The shape of the trees would be recaptured. He explained that the quote is 150 dollars per tree due to the amount of work involved with invasive weeds. Mr. Pineo felt that there was nothing special with the apple varieties to save. He further explained that the vies and overgrowth was causing the most damage to the trees. Chair Roberti noted he identified 40 trees- she asked if there was a possibility that he could reduce the number of trees? He said if they wanted to cut it in half ( 20 trees ) . He stated he can do the project anytime. MM suggested do half now and see the response. With funding coming in from a forestry cut the other half could be more affordable if the initial project was successful. Messers Marro and Faucher recommended that a good start is the 20 trees in the front part of the orchard. Chair Roberti noted that Mr. Faucher's professional opinion should be trusted to decide the trees to prune. Mr. Pineo state he is against the idea and that there would be no need for the commission to walk it as he feels Mr. Faucher's judgment could be trusted and that an aesthetic cutting be the goal with productive trees used for educational purposes in the future. Ms. Valentine motioned to have Mr. Faucher prune 20 trees per the proposal. Mr Pineo seconded and the commission voted 4 yes with Mr. Pineo abstaining.

5. Enforcement/Investigation- Investigation of flooding situations at 17 Mortimer Road/Justice Hill- Pat Dell from Mortimer Road and Lynda Kelley from Justice Hill Road attended and Messers Marro and Pineo described site meetings and outlined the storm water and flooding issues. Mr. Marro noted he was informed that DCR is amenable to the town doing remedial work on the sites. After some discussion of potential state funding mechanisms for private contractors to perform the work, Mr. Marro noted to the commission the town administrator is going to explore the work needed to be done with Both Mr. Marro and Bill Tuttle. The commission instructed Mr. Marro to continue working with Mr. Tuttle and explore the site.

to complete some spot grading to ensure a flat spot would not be created. He also inquired on how the electric utility would be connected. Mr. Pavlowich commented that the calculations were sufficient. Mr. Marro recommended a negative determination and a standard storm water permit.

Mr. Michalak moved for a negative 3 determination and a standard storm water permit with the recommended added port. Mr. Pavlowich seconded and the commission approved with a unanimous vote.
