He noted that the invasives are migrating to Elliot Road. He also indicated that he spoke to U MASS extension and they recommended an invasives management program.

Mr. Marro indicated that he viewed the Justice Hill area and agrees that there is a potential for a severe problem that is occurring.

Chair Roberti indicated that as DCR is the largest landowner in this area the commission could reach out DCR for assistance.

Mr. Cormier indicated that UMASS is able to come out and hold a public outreach session to educate residents. Chair Roberti indicated that a combination of this commission, OSIC and DCR can likely combine to start some public outreach and investigate any grant programs. Mr. Curtin recommended that Mr. Cormier also go to speak to the DPW Board to see what programs they have existing and how they may be able to help as well.

The Commission is going to examine having U MASS extension to inquire if they can come to the Sterling fair in the fall as well. Mr. Marro is going to speak with state officials to examining the regulations.
