The meeting was re-scheduled to the next regular meeting

8:00 PM : Pursuant to <u>Local Storm Water By-Law</u>, the Sterling Conservation Commission will have a CONTINUED public meeting on a <u>storm water permit</u> and a Notice of Intent request by James Simpson for the Construction of 18 Condominium Units at 39 Flanagan Hill Road

The Commission reconvened the meeting. Alton Stone once again objected to the plans stating he did not see a wetland delineation and objected to the riverfront drawing. He stated it appeared to him there was no survey work done on the high water mark. James Rheault representing Mr. Simpson state there was a survey done and we would produce a wetland report. Karen Gostenhoffer echoed Mr Stones Comments. Abutter Pulda noted that the area had been flooding and was concerned about water increased.

Commissioner Pavlowich had examined the storm water system and had requested the applicant examine the possibility of moving the catch basin hardware farther up the road to intercept water sooner to address potential water volume increases. He further requested DPW also comment on the same possibility.

After some debate, the commission continued the hearing to November 13, 2018 with the applicant completing the following:

- Survey and high water mark re-flagging on the site and confirmed for the plans.
- Go to DPW for comment on the storm water system
- Produce a wetland delineation report
- Site inspection scheduled for November 5, 2018 at 3:30 PM

The Continuance was greed to and granted by a unanimous vote on motion by Mr. Pavlowich and a second by Ms Valentine
