#### Abandoned/Nuisance Property. R. Perry

- Sterling Inn. Still looking for funding. She has been making progress in her quest for answers/direction. There may be an additional person interested in the property.
- 3 Princeton Road. No movement Owner may consider rehabbing the building.
- Gun Shop on School Street. No movement.
- Domenica asked if there were a listing of the properties that are under this umbrella and if they are placed in any particular category
  - Maureen C will send her a the listing. It was stated that the list was formulated by many boards/committees and Fire and Police Departments.
  - It was stated to Domenica that the BOS had sent out letters to the delinquent property owners 2 years ago to then again last year. Not many responded.
- Sarah, Building Commissioner, has been diligent in pursuing the properties.

#### **40B Housing**

• 40B Housing. Concerns from Abutters for this project (Chase Hill Road). BOS offered space for the Abutters and Builders to talk to mitigate the impact.

#### **Facade Program**

• Sterling may be looking into a Facade Program whereby the owners may be assisted in purchasing paint for refurbishing their facade or may get some type of tax advantage....

- Richard M stated they "had a meeting"
- Barbara Roberti (Lake Association) stated that Mr. Stone would do a soil test/septic test. The test was completed and tested positive for micro-biological contamination. Suggestions of a tight tank or 2 may work. D. Favereau suggested a Presby system.
- there is also a major erosion problem dealing with "storm water" from Swett Hill Road working its way down to the beach and then consequently running into the lake
- B. Roberti gave a presentation the BOS last week. She suggested that the beautification of the area be on hold till the septic system is addressed.
- There is a slightly less than \$1M bond for improvements at the Town Beach
