Town of Sterling Finance Committee Meeting Minutes May 13, 2021 Zoom

Finance Committee meeting called to order by Todd Chapman at 6:00pm

Fincom Attendees: Todd Chapman, Mary Cliett, Chris Paquette, George Handy Ezequiel Ayala

Also Attending: Fred Aponte, Town Accountant, Kellie Hebert, Town Administrator, Valerie

Handy, Recording Secretary for Fincom and CBC.

Meeting started with a recap and summary of issues affecting the town. Cherry Sheet State Revenue has increased \$36K. Tax Levy of \$21,135,680 required to be raised by real estate taxes. A discussion followed regarding the definition of Tax Levy and Maximum Tax Levy. George Handy volunteered to send out links to the members from the Division of Local Services and a DLS seminar and workshop of Levy Limits and Proposition of 2 ½.

Todd Chapman shared a document showing how since FY17 average taxes have gone up. In FY19 the average taxes were \$5916. In FY20 taxes increased 3.26% to \$6109. In FY21 they increased 2.16% to \$6241. The estimated increase for FY22 is 3.68% if all spending under consideration is passed, with an estimated average tax bill of \$6,470 for the average single family home.

Discussion then followed on Omnibus Budget. Overall, the Budget increased 2.98% if all spending under consideration is passed (this includes the town operations, schools, land trust and firefighters).

The Committee then reviewed changes to the budget since our last review. Board of Health wages increased \$16,852., increase of 13.47%. This was due to the addition of one-half salaried position, position hours increase from 19 to 32 and COVID reimbursement wages. It was noted that the BOH wages line went from zero in 2020 to \$80K in 2022.

- (Pg.2) DPW trash pickup costs decreased \$36k.
- (Pg.3) Fire/EMT \$62,286 has been pulled out this part of the budget and added at the end. (Pg.4) No changes
- (Pg.5) Police budget increase is now 1.17%, excluding the new patrol officer position which was moved to the end of the budget. Including this position the Police budget shows a 3.01% increase over the prior year.

Planning Budget wage increase by \$15,250 to \$37,260. Due to part-time 19 hours increasing to 32 hours (Pg.7) Town Administrator- Increase \$7,500 (senior tax work off)

Town Clerk – Decrease \$2,216 since our prior review. Represents 4.5% decrease from prior year.

(Pg.8) No changes
