TOWN OF STERLING BOARD OF SELECTMEN March 31, 2016

MEETING:Chairman Cutler called the meeting to order at 8:03 AM. Roll Call: Selectwoman Cranson - absent.Selectman Kilcoyne – Present. Chairman Cutler – present.

Regional Dispatch
discussionA survey was recently sent to the Chief of Police and the Town Administrator, regarding regionalization of
Dispatch services. The Chief requested guidance for the Board in regard to whether or not they wanted him
to answer the survey and if they wanted to pursue information on regionalization. Chief Chamberland
stated that the move to regionalization of Dispatching service would impact citizen convenience. However,
he also stated that the State strongly supports regionalization of these services and ultimately, it may not
only prove to be the most fiscally sound course of action, but the State may force the issue in the not too
distant future. Changing the dispatch service to an out of town, regionalization service requires an article to
be passed at Town Meeting. After discussion: Selectman Kilcoyne moved that the Chief of Police, Fire Chief
and the Town Administrator collaboratively fill out the survey and to begin gathering information regarding
this issue. Selectman Kilcoyne – Aye. Chairman Cutler – Aye. Motion carried. The Board requested that they
initiate Regional Community forums to answer questions regarding this issue.

ATM/STM Warrant Previously HELD articles, that have been researched/amended, were discussed.

STM Article 8. Transfer from 2016 WRSD Assessment

After discussion, Selectman Kilcoyne moved that the Board make their recommendation at town meeting. Chairman Cutler 2nd. Selectman Kilcoyne – Aye. Chairman Cutler – Aye. Motion Carried. The Board is concerned that the approval of this article will cause the Town to bear a disproportionate amount for technology infrastructure in the schools. Since this goal is part of the schools 5 year tech plan, the Town would be paying a portion of the cost for updating all of the schools in the near future after funding its own. Therefore, the Board wishes to have input from the School Committee.

ATM Article 6. WRSD Above Net Minimum Contribution

The article has been amended to reflect that appropriated taxes that exceed the final School assessment will be returned to the town. In the future, the tax rate will reflect the reduced assessment. Selectman Kilcoyne moved that the Board include and endorse this article. Chairman Cutler 2^{nd} . Selectman Kilcoyne – Aye. Chairman Cutler – Aye. Motion Carried.

ATM Article 13. Amendments to Personnel Policy Bylaw Classification and Compensation

The Personnel Policy Bylaw has been updated to reflect current realities. Selectman Kilcoyne suggested that information in the warrant be watermarked "current" and "updated" to alleviate any confusion at Town Meeting. Selectman Kilcoyne moved that the Board endorse this article as written. Chairman Cutler 2nd. Selectman Kilcoyne – Aye. Chairman Cutler – Aye. Motion Carried.

Article 20. Revolving Accounts

The recycling appropriation in the revolving account has been reduced to \$5000.00. It may be removed from the revolving accounts next year and placed as a raised and appropriated expense.

The Radio Master Box fees have been increased by \$1000.00 due to increased costs for the service.

The Wiring Inspector's stipend has been added as an additional revolving fund that may be paid as per each fee charged for his inspectional services. Selectman Kilcoyne moved that the Board endorse this article as written/adjusted. Chairman Cutler 2nd. Selectman Kilcoyne – Aye. Chairman Cutler – Aye. Motion Carried.
