Chair Cranson called the Select Board meeting to order at 6:30 pm. Roll Call: Chair Cranson – Present. Select member Newman – Present. Select member Smith – Present.

Town Administrator, Bill Caldwell – present. Senior Executive Administrative Assistant, Kama Jayne - present.

Minutes

Select member Newman moved to approve the October 11, 2023 minutes, as written. Chair Cranson – 2nd. Select member Newman – Aye. Chair Cranson – Aye. Select member Smith – Abstained. Motion carried.

OML Complaint

On October 5th, the board received an Open Meeting Law Complaint from Russell Williston regarding the Board's decision to go into executive session on September 27th. Mr. Williston maintains that the executive session was not appropriate. After discussion, select member Newman moved that the board acknowledge receipt of the OML complaint concerning the Board's September 27, 2023 executive session and to authorize Town counsel to respond on the Board's behalf. Select member Smith – 2nd. Select member Newman – Aye. Chair Cranson – Aye. Select member Smith – Aye. Motion carried.

Housing Authority Appointment The Housing Authority has requested that the select board forward a recommendation for an additional person to be appointed, by the State, to the Sterling Housing Authority. Currently, the four-member committee results in instances of split votes. The board encourages anyone who may be interested in filling the position to contact the Select Board office.

STM Results

- At the Special Town Meeting, the voters, by vast majority, approved the citizen's petition which urges the Board of Health to rescind their Dec. 8, 2022 revisions to Sterling's Subsurface Disposal System Regulations. While they have no jurisdiction over any other elected board, the consensus of the select board was to support the voters in this matter. Therefore, select member Newman moved to send a letter to the BOH board strongly suggesting that they rescind their regulation. Select member Smith 2nd. Select member Newman Aye. Chair Cranson Aye. Select member Smith Aye. Motion carried.
- The citizen's petition to audit the Board of Health also passed at the Town meeting. Therefore, the select board will appoint one of their members to participate in that audit.
- The chair reiterated that although there were typos, in one of the citizen's petition included in the warrant, they were simply human error. Once alerted to the mistakes, the errors were immediately addressed. The corrected article verbiage was posted on the website and hard copies of the corrected petition article were available at the Town Meeting. In the future, citizen petitions will need to be submitted in electronic format and warrants will have additional reviews prior to going to print.
- The only article that did not pass at Town Meeting was the school article requesting changes to the school agreement which would impact membership in the school committee.

Select member Newman moved to sign the warrant for the 2023 Special State Election. Select member $Smith - 2^{nd}$. Select member Newman – Aye. Chair Cranson – Aye. Select member Smith - Aye. Motion carried. That special election will be held on November 7^{th} .
