She assesses need, provides information, makes referrals, and provides application assistance as necessary. Her goal is to meet every senior in town and she invited any and all to stop by the senior center to meet with her or to call to make arrangements for a home visit. Veronica reported that the Senior Center has been active in working, along with other departments and Boards, in their mission to make the Town age and dementia friendly. EDC Appointment	EDC appointment is tabled until the next meeting.	
Discussion - Earth Removal permit on Chocksett Road	<ul> <li>There has been a considerable issue with excessive dust and debris on Chocksett Road and Route 12 caused by the Earth Removal operation on Chocksett Road. The Operations manager, Mandy DeFreest reported to the Board that steps to rectify these problems have been taken; <ul> <li>Tracking Pads have been extended</li> <li>Plans are underway to pave from the entrance to the scale house</li> <li>Onyx has purchased their own sweepers so as to be able to address spills immediately</li> <li>Sprayers will be used to quell the dust issue</li> <li>Employees are sent out multiple times daily to check for "issues" along the roadways, so that they can be immediately addressed</li> </ul> </li> <li>Allen Hoffman, Chair for the Board of Health reported that the BOH is concerned about the dust, citing its detrimental effects upon citizen's health. The Select Board requested that the BOH submit their concerns in writing.</li> <li>The consensus of the Select Board, is to forgo sanctions, at this time. They are hopeful that the remedial actions taken by Onyx, along with consistent maintenance, will prevent further problems. If such is not the case, the Board may reconsider its course of action in the future.</li> </ul>	
Disband Senior Center Building Committee	After discussion, Select member Kilcoyne moved to disband the Senior Center Building Committee. Select member Smith 2 <sup>nd</sup> . Chair Cranson – Aye. Select member Kilcoyne – Aye. Select member Smith - Aye. Motion carried.	
Disbursement of SCBC funds	Currently, the former SCBC members and the Council on Aging members are at odds. It is the opinion of the former SCBC members that the remaining Senior Center Building Funds should be used to construct a sun shelter over the patio, as was part of the initial building plan. The COA would like to immediately use a portion of the remaining funds toward the first phase of landscaping. They propose that remaining funds, along with donations, grants and fund raising, be used to then construct the sun shelter and complete the landscape design in phases. The landscape committee will forward their plan to the Select Board members who will take both sides into consideration prior to addressing this topic at a future meeting.	
ARPA funding for Downtown renovation	The Town Administrator has proposed that ARPA funds be approved for disbursement to cover the cost of placing the Comcast cables underground, as part of the Downtown Renovation Project. After discussion, Select member Kilcoyne moved to approve the disbursal of \$153,068.00 in ARPA funds to pay for the placement of the Comcast underground cables. Select member Smith 2 <sup>nd</sup> . Chair Cranson – Aye. Select member Kilcoyne – Aye. Select member Smith - Aye. Motion carried.	
Oil Contract	The Town Administrator presented a fuel oil contract, with Fraticelli Oil, for approval by the Board. After discussion, Select member Kilcoyne moved that the Board approve the Fuel Oil Contract with Fraticelli Oil. Select member Smith 2 <sup>nd</sup> . Chair Cranson – Aye. Select member Kilcoyne – Aye. Select member Smith - Aye. Motion carried. The contract will run from October 27 <sup>th</sup> – June 30 <sup>th</sup> , 2023. The price for oil will be 4.499 per gallon and the agreement shall not exceed \$50,000.00.
