The Montachusett Regional Planning Commission is pursuing an Economic Adjustment Assistance grant from the US Economic Development Administration to complete their planning project for (FILLTERR) – Future Industrial Lands for Long Term Economic Recovery and Resiliency. This project will help local area towns prepare for expansion of businesses in the future. Therefore, Select member Kilcoyne moved to support the MRPC's pursuit of this \$134,073.00 grant, to conduct this comprehensive analysis. Select member Smith – 2<sup>nd</sup>.
