Property Lister – Harald interviewed Jim Chambers for the position. He doesn't have any direct experience, but there will be training - RRG has an annual workshop in early April. He has some potential background experience that might help with some of what he'll be doing. The Board might want to try him out for a season.

Abatements – Harald has an administrative abatement for David Rota, whose barn burnt down on March 10^{th} – the law allows us in a situation like this to prorate the assessment – Harald put together an abatement that would abate part of the taxes (\$136.00) for the barn.
