MEETING:

Chairman Kilcoyne called the Select Board meeting to order at 6:31pm. Roll Call: Selectman Cranson – Present. Selectwoman Sonnenberg – Present. Chairman Kilcoyne – Present.

Minutes

Selectman Cranson moved to approve the minutes of July 10, 2019, as written. Selectwoman Sonnenberg 2nd. Chairman Kilcoyne – Aye. Selectman Cranson – Aye. Selectwoman Sonnenberg – Aye. Motion Carried.

61A Releases Justice Hill Road and Maple Street The Public Hearing was delayed to see if the requesting parties would attend. Then at 6:48, Selectman Cranson moved to open the Public Hearing, regarding the release of Chapter 61A land on Justice Hill Road, Map 18, Lot 1 and the land owned by Anthony and Diane Melone on Maple Street, Lot 2. Selectwoman Sonnenberg 2nd. Chairman Kilcoyne – Aye. Selectman Cranson – Aye. Selectwoman Sonnenberg – Aye. Motion Carried.

The Planning Board, Conservation Commission and the Assessors have all voted to approve the release of the land owned by Justice Hill, INC from Chapter 61A and not to pursue the purchase of this property. After discussion, the public was invited to speak. No one opposed the release. Selectman Cranson moved to approve the release of the 61A chapter land (Lot 1) on Justice Hill Road, owned by Justice Hill, INC. Selectwoman Sonnenberg 2nd. Selectman Cranson – Aye. Chairman Kilcoyne – Aye. Selectwoman Sonnenberg – Aye. Motion carried.

The Planning Board, Conservation Commission and the Assessors have all voted to approve the release the land (Lot 2), owned by the Melones on Maple Street from Chapter 61A and not to pursue the purchase of this property. After discussion, the public was invited to speak. No one opposed the release of this property. Selectman Cranson moved to approve the release of Lot 2 on Maple Street from 61A chapter land. The Board considered the requested approval of a curb cut for driveway access to the proposed building on **64 South Nelson Road**. No trees or stone walls will be removed. The application was approved by the DPW, Fire Department and Building Commissioner. TA Report

Town Administrator Report 8/7/19 in my absence, by Fred Aponte Operations Manager

- Patrice Fullhart, the Town's new Facilities Technician has been here three weeks and is already working hard to make improvements in the Town's buildings.
- 1835 Building, RP is working with building committee with Patrice's help to finish the junk removal. Then we plan to review the details of the top to bottom clean up and decide when to have the building cleaned. The Rec Dept. is very interested in holding programs in the building starting as soon as the building is cleaned. What is the Boards preference?
- A couple companies that might be able to design the sprinkler system have been contacted. But the installation date is still TBD and at least multiple months away.
- The HVAC system the Police Station has failed due to a bad compressor leaving half the building without AC. We decided that investing \$4,000 to fix a failing system was not appropriate. Accordingly, a couple window and portable air conditioners were purchased. We will find someone to evaluate the overall system and provide plans for a fix or replacement. Most likely this will be an FY 21 capital project.

- The Fair Committee is considering a traffic pattern change for this year.
