TOWN OF STERLING **BOARD OF SELECTMEN** March 27, 2013

MEETING:

Chairman Sushchyk called the meeting to order at 6:35pm. Roll call established that Paul Sushchyk, Ron Furmaniuk and Brain Patacchiola were present. VOTE: Selectman Furmaniuk made the motion to approve the agenda. Selectman Patacchiola 2nd. All in favor.

VOTE: Selectman Furmaniuk made a motion to enter into Executive Session regarding Contract Negotiations. Selectman Patacchiola 2nd. **Roll Call Vote**. Chairman Sushchyk – Aye. Selectman Furmaniuk – Aye. Selectman Patacchiola – Aye. The public was asked to leave the room.

The public meeting resumed at 7:08.

VOTE: Selectman Patacchiola made the motion to approve the minutes of March 13, 2013. 2nd by Selectman Furmaniuk. Selectman Sushchyk abstained because he did not participate in the regular meeting, on March 13.

Legislative Update:

Present Representative Kimberly Ferguson and Representative Harold Naughton

The Representatives reported briefly on the proposed State budget. They are hopeful that local state aid will be level funded. They encouraged constituents to communicate with them so that they may better represented at the State level. The Select Board asked questions regarding the budget and legislation regarding the Medical Marijuana Law.

School update:

Both Representative Kimberly Ferguson and Representative Harold Naughton thanked the Town Administrator, Terri Ackerman for her excellent communications with their offices.

Lance Harris was present to give an update on the school system. He discussed the following:

- The school budget, depending upon State aid, is expected to pass along an increase of less than 1% to the Sterling tax payers.
- The Regional School Committee will eventually, as terms expire, decrease to 12 members. Their votes will be weighted depending upon population.
- The Thomas Prince School, in Princeton, that will be offered as an alternate school for students who wish to a more technical education. WPI will partner in this effort.

Sterling National Country Club Seasonal License renewal On April 24th the school administrative staff will give a presentation to the Board of Selectmen. The Board commended the School Committee on a job well done.
