Injured on Duty Insurance Renewal

The Town of Sterling has negotiated and will renew their Injured on Duty Coverage for the Police and Fire Departments through Cook and Company Insurance Services, Inc. The total cost will be \$25,339.00.

Caitlin Sabourin and Sarah Basinger, of Sterling will receive the Silver Award at a ceremony at the College of the Holy Cross on Saturday, June 14, 2014.
