#### Clerk

Miller moved that the Board appoint David Shapiro as Clerk. Page seconded the motion. The motion passed unanimously.

#### ANR Agent

Santoro moved that the Board appoint Patty Page as ANR Agent. Miller seconded the motion. The motion passed unanimously.

## MRPC ~ Member Representative

Shapiro moved that the Board appoint Patty Page as the Board's representative to the Montachusett Regional Planning Commission. Miller seconded the motion. The motion passed unanimously.

## MJTC - Alternate ~ P.B. Representative

The Board agreed to table this appointment pending a viable candidate.

## Master Plan Committee ~ P.B. Representative

The Board agreed this appointment was not applicable at this time.

# Affordable Housing Plan Committee ~ P.B. Representative

Philpot moved that the Board appoint David Shapiro as the Board's representative to the Affordable Housing Plan Committee. Santoro seconded the motion. The motion passed unanimously.

# Earth Removal Board P.B. Representative

Philpot moved that the Board appoint Craig Miller as the Board's representative to the Earth Removal Board. Shapiro seconded the motion. The motion passed unanimously.

#### Minutes

Miller moved that the Board approve the minutes of May 8, 2019 as amended. Santoro seconded the motion. The motion passed with four in favor and one abstain (Page was not on the Board).

#### Warrants & Payroll

Board Members reviewed a payroll warrant and warrants for WB Mason and Telegram & Gazette.

## <u>Discuss and take any action necessary relative to Gibson Dairy dba Cream Crock</u> <u>Distributors, 48-50 Worcester Road</u>

Mr. Fran Gibson of Gibson Dairy along with Michael Burke, Burke Engineering were on hand to present the site plan for 48-50 Worcester Road, Sterling, MA. Gibson gave a brief synopsis of the activity. Gibson confirmed that he did not anticipate any additional changes to the plans presented.

Philpot stated that the next steps in the process would be a reviewed by the Town's Engineer as well as various departments.

#### **Discuss Earth Removal Bylaws**

Mr. Jeff Donaldson spoke about his suggestions for the Earth Removal Bylaws.

After a discussion, Board Members agreed that it would be a good idea to go back and put the former ERB Working Group together and to consider a role for Mr. Donaldson if he should want it. (Shapiro, Miller, Pat Fox and Mike Rivers).

Philpot agreed to reach out to the ZBA and ERB.

## **Board Policy: Planning Board representation**

Philpot expressed concerns over Board Members not indicating that they are expressing their opinions as a private citizen and not that of the Planning Board in outside discussions.

Mr. Donaldson suggested whenever appropriate to give a full disclosure that 'the opinions expressed are my own and not representation of the Board'.

Philpot felt it would be healthy for the Board to establish a policy in writing which gives the Board and the individual something to stand on and be backed up. Philpot will reach out to other Boards to see what their words are.

#### **Town Planner's Report/Discussions**

Philpot stated the Board has not received a report from the Town Planner.

Town Planner reported that the Town Clerk has submitted all her amended Bylaw reports to the Attorney General's office. EDC working with the microbrewery business startup. She will be absent at the next meeting scheduled for June 12, 2019. Tatasciore last comment referred to her memo dated May 23, 2019 regarding the Master Plan Charge.

Philpot acknowledged that all members received this memo from the Town Planner relating to the Board of Selectmen appointing the MPC and the BOS approving the MPC charge. Philpot suggested this discussion be taken up at the June  $26^{th}$  meeting.

Tatasciore informed the Board that moving forward she would be reading her report at the Planning Board meeting. Philpot asked if it would be possible to get a written copy and Tatasciore' responded "not before the meeting" but will provide a hard copy to the Board after.

#### **MRPC**

Philpot acknowledged email from MRPC for Draft FY2020 Unified Planning Work Program.

### Request to be read into the meeting minutes

Philpot read an email dated May 20, 2019 from Rosanne Mapp. (See Attachment A)

Philpot asked the Board if they had any comments.

Philpot clarified the comment in the letter indicating 'that the Planning Board Public Session seems to have been eliminated'. Philpot stated that the Planning Board has never had a Public Session on their agenda.

Personal issues with certain Board and Committees ~ Philpot stated he does not have any personal issues with people. He has professional issues. As a member of this Board Philpot has a professional issue with the Board of Selectmen with the appointment they are about to make that is on their agenda for tonight which abrogates our authority with respect to Master Plan Committees. It erodes the authority of this Board and violates Mass General Law.

Page asked why can't we have a public session. Philpot response was the OML does not require any board or public body to allow public input it is at the discretion of the Chair.

Ms. Mapp stated her letter had nothing to do about what this Board has to do on a regular basis. The topic was the Master Plan.

# Administrative Assistant's Report/Notices

Kazan informed the Board that the Planning office would be closed on Monday, June 17 and Tuesday, June 18.

## Upcoming applications

Kazan informed the Board that she anticipated an ANR for 181 Clinton Road and Site Plan for NEADS, Leominster Road at a future meeting.

#### June 12 Meeting

Philpot may not be at the June 12<sup>th</sup> meeting. The Board will wait until next Tuesday which is the deadline to get on the agenda before deciding whether to hold this meeting.

#### Discuss e-mail communication and potential OML Violation

Philpot expressed concerns over an e-mail communication that Ross Perry sent to him and copied the entire Board.

Philpot read a series of emails sent by himself, Patty Page and Ross Perry. (See Attachment B)

Page stated that she spoke with someone from the Attorney General's office and they told her this was not an OML violation.

Philpot read an email he sent to the AG's office Open Meeting Law Division and their response. (See Attachment C):

Philpot stated that it seems to him according to this person at the AG's office that Page expressed an opinion and violated the Open Meeting Law.

Page stated she disagreed with this and did not think she violated anything. She stated go ahead and file a complaint.

Philpot stated we would leave it there and see what happens. Shapiro recommended that the Board not pursue this.

After a discussion, Board Members were all in agreement for Philpot to meet with Perry 1 on 1.

Good morning Mr. Philpot,

We generally caution public body members to be careful when communicating via email, as emails between public body members often constitute "deliberation" outside of an open meeting.

The Open Meeting Law defines deliberation as "an oral or written communication through any medium, including electronic mail, between or among a quorum of a public body on any public business within its jurisdiction." Distribution of a meeting agenda, scheduling or procedural information, or reports or documents that may be discussed at a meeting is often helpful to public body members when preparing for upcoming meetings. These are the types of communications that are considered to be "administrative" in nature and generally will not constitute deliberation.

We have said that discussion of a public body's operation is public business within the public body's jurisdiction. Opinions about personnel would likely be considered "board business" and as such, these opinions should be shared only in an open meeting. Unfortunately, what starts as a purely administrative discussion (scheduling a meeting) may quickly turn into a discussion about board business.
