Final As-built – 146 Pratts Junction Road - Gagnon Melinda Westberry presented the revised final as-built plan to the Board with the additional information requested at the April 22, 2021 meeting. Patty Page made a motion to accept the final as-built. Kirsten Newman seconded. All in favor 3-0.

Final As-built – 150 Clinton Road – Storage Solutions Matt Waterman of LandTech presented the final as-built plan to the Board with the additional information requested at the April 22, 2021. Kirsten Newman accept the final as-built. Patty Page seconded. All in favor 3-0

Site Plan Review – 104-106 Leominster Road (John Santoro joined the meeting at 6:39 pm). William Wyskoczka of WPW Properties presented his site plan for 104-106 Leominster Road (parcel ID 65-31). The location was previously a medical office and the new proposed use is a daycare. This change in use has triggered the requirement for site plan review. Mr. Wyskoczka stated his original intent was another medical facility, then a tenant expressed interest in leasing the entire building. Chairman Corrinne reviewed a number of conditions of approval for the site plan. These include:

- accessible parking with van-accessibly access aisle;
- a striped and demarcated crosswalk from the building to the playground;
- bollards surrounding the playground area;
- dumpster location if used;
- snow storage areas;
- submission of as-built plan within 30 days of completion of the project and before certificate of occupancy is issued; and
- that the project will be constructed in substantial accordance with the final revised plans.

Patty Page made a motion to conditional approve the site plan with the above conditions. Kirsten Newman seconded. All in favor, 4-0.

ANRs – Chace Hill & Charles Patten Dr.

The board reviewed an ANR for 86 Chace Hill Road. Patty Page made a motion to endorse the ANR as presented, Kirsten Newman seconded. All in favor, 4-0.

The ANR plan for Charles Patten Drive was not received in time for this meeting.

MJTC Appointment

Kirsten Newman agreed to continue as the MJTC representative for Sterling.

Master Plan Update Patty Page updated the Board on the Master Plan. VHB (consultant) and MRPC have provided the Master Plan Committee with goals and actions for a number of chapters for review. Once the committee has forwarded their comments to the consultant and MRPC, the draft documents will be added to the Master Plan web page to encourage public participation. Next meeting is scheduled for June 24, 2021 and 6:30 pm.
