Minutes

Robert Protano made a motion to approve the minutes of October 7, 2020 as written, Kirsten Newman seconding. The motion passed by a vote of 5-0.

Public Hearing – Protective Bylaw Amendments Patty Page made a motion to postpone the Public Hearing until December 16, 2020 at 6:35 pm. Kirsten Newman seconding. The motion passed by a vote of 5-0.

114 Pratts Junction Rd – As-Built Plans

After discussion and review of the peer review engineer report, Patty Page made a motion to accept the As-Built plans for 114 Pratts Junction Road. Kirsten Newman seconding. The motion passed by a vote of 5-0.

Chapter 61A Releases Rob Protano made a motion to recommend that the town not purchase lots 16, 17 and 18, Justice Hill Road, portion of parcel ID 18-17. Patty Page seconding. The motion passed by a vote 5-0.

ANRs

Two ANR (Approval Not Required under Subdivision Control Law) plans were presented to the Board. One for Lot 6, Justice Hill Road (Map 18, Parcel 16), and Lots 12 to14, Justice Hill Road and Roper Road (Map 18, Parcel 17). Patty Page made a motion to endorse both ANR plans as presented with Kirsten Newman seconding. The motion passed by a vote of 5-0.

Master Plan Update Patty Page updated the Board on the Master Plan Committee activities. There is currently a survey poll on the website that closes at the end of November. These poll questions were presented at the November 12, 2020 Virtual Public Meeting which had live participation and interactive polls throughout the meeting. The Committee's next regular meeting will follow on December 17, 2020.

Engineering Consultant Carl Corrinne announced that the Board has contracted with Graves Engineering as the new peer review engineer. The Board will also have Green Engineering as a back-up as needed.

The Board had agreed to have meetings on the fourth Thursday of the month going forward. This is to avoid scheduling conflicts with the already busy Wednesday evenings. The following are agreed up dates: December 16, 2020, January 28, 2021, February 25, 2021 and March 25, 2021.
