Tennis Court Update

- Chuck presented a Photo Report 1 of the project progress, Work Schedule, and Project Budget
 - o Estimated Final Cleanup Week of 8/11/2019, Kristen will put signs and a lock to prevent use until it is ready
 - Suggested: To remove the trees at the southeast corner of the basketball court due to the risk of them damaging
 the new court, Chuck talked to DPW with no commitment, Chuck approached a local tree service for a quote
 with no quote provided on time, the current contractor will remove the trees for an additional cost
 - o Project Budget has been adjusted
 - Fence Demo done by contractor and not DPW (\$4000)
 - Add a handicap ramp and double handrail (\$500, \$1000, \$1509)
 - O Discussion: Concern for when DPW will install the trench drain and the trucks being on the new court, Chuck assured it will be a distance from the court and installation should not affect the integrity
