The bank has recently acquired, through foreclosure, the house on lot 17. A survey has shown that the driveway for that property is located on lot 16. It is the desire of the bank to acquire the lot, upon which the driveway is located, in order to sell the entire property to a third party.

Police Report

The following are some brief highlights as to some activities of the Police Chief and the Police Department for the month of April 2015.

Personnel, Training and Equipment:

- Officer Ferguson became a trainer in the administration of Naloxone, and has trained all department personnel.
- All dispatchers have been recertified in CPR and AED.
- Dispatchers undergoing annual mandatory training, currently taking legal update class & Liability for 911 Emergency Dispatching.
- Replaced a battery at the main radio site generator. Work performed by the SMLD.
- Special Order pertaining to uniforms issued.
- All filters changed in air handlers in the station

Community Interaction:

- Conducted a lock down drill at the schools.
- Assisted with the Promenade Walk.
- Assisted with opening day and parade for Sterling Little League.
- Spoke at a meeting of the Sterling Chocksett Club.

General Police Business:

- Four arrests during the month. Two for operating under the influence, one motor vehicle offenses, one protective custody.
- Eighty-one motor vehicle stops, 55 citations issued.
- Sixteen crashes during the month.

Neighbor to Neighbor

Lisa Call addressed the Board on behalf of the Neighbor to Neighbor Fund. She recommended: For Applicant P. family: help with both its electric and oil bill. Applicant will pay the new charges on electric bill, plus \$25 for the next three months. NtN will then pay \$379.43. This would settle all past charges and SMLD will waive any late fees that would typically be added. Additionally, the family will pay \$600.00 of the current balance of \$1355.46 to Brideau Oil, over the next 12 months. The

recommendation for pay out from Neighbor to Neighbor to Brideau is \$755.46. The total recommended disbursement is \$1134.89.

Recommendation for Applicant W: Family has just managed to paid \$1600.00 of their delinquent property taxes which had totaled \$2868.38, with the help of distant family. Therefore, NtN will pay \$1200 toward the taxes, in order to keep the property from auction.

After discussion VOTE: Selectman Kilcoyne moved to disburse the recommended funds for both Neighbor to Neighbor applicants. Chairman Cutler 2nd. Selectman Kilcoyne – Aye. Chairman Cutler - Aye. Selectwoman Cranson – Aye. Motion Carried.

Selectman Kilcoyne will be meeting with the Neighbor to Neighbor Committee to discuss the formation of a more formal entity for the organization.

TA Report

- The Sheriff's department has completed the painting of the South side of the 1835 Town Hall in record time. Since they have left over paint and time, they will also paint a small, off site, garage that is used by the Fire Department.
- Mr. Amrith Kumar, the newly elected Moderator has asked that the Board address the following, relative to Town Meeting:
- 1. (a) A better PC?
 - (b) A better projector?
 - (c) What can be done to repair or fix the faulty microphones?
 - (d) The possibility of electronic voting via 'clickers'
 - (e) Is the SLCT able to help the Town with any or all of these items?
- 2. Simplification of the warrant process.
- 3. Immediate scheduling and organization of the upcoming Special Town Meeting.
- 4. Immediate scheduling and organization of the next ATM, with consideration so as to avoid scheduling conflicts with Lancaster and the Cable Company.

The Board and Town Administrator will consider and work toward these common goals to be addressed at a future meeting.

- Chairman Cutler proposed having board and committees occasionally attend Selectmen
 Meetings so that the Board stays abreast of the goals and responsibilities of all the Boards and
 Committees.
- The Senior Center received 6 bids which were opened today. The responses were within the
 anticipated range and the Architects and the OPM were satisfied with the responses. The
 bidders will be certified.
- Another cherry sheet was received recently and it indicates that the proposed Senate Budget will virtually level fund the Town.

Public Session

Former Selectman Patacchiola addressed the Board and offered to continue to serve and support the community by serving on a committee(s) or Board(s) if the Select Board should feel it would be helpful. The Board thanked Mr. Patacchiola for his service.

Executive Session

At 8:15 Chairman Cutler stated that that the Board would be entering executive session to discuss a proposed separation agreement and that the Board must approve any such agreement in open session. To conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel; Separation Agreement – Donald Jacobs. Selectman Kilcoyne 2nd. Roll Call Vote. Selectman Kilcoyne – Aye. Selectman Cutler - Aye. Selectwoman Cranson – Aye. Motion Carried. The Board convened in Executive session.
