2) Approval of Agenda – **Piece made a motion to approve agenda as amended**, removing item 6, Darlington seconded, no discussion, all in favor, Darlington aye, Curtin aye, Pierce aye.

3) Manager's report given by Darren Borge

- The Sterling Selectboard voted to transfer funds from ARPA on 11/22/2021 in the amount of \$352,000 to SMLD and to appoint Borge to the Hazard Mitigation Team and Energy Committee.
- Borge presented a concept plan for a lean-to addition for 27 Pratts Junction Road Warehouse to increase storage.

4) Unfinished Business

- a) Fiber Project/American Rescue Plan-
 - Update and Schedule for sections completed and ready for customer connections: All cabinets and
 fiber to home equipment tested and available for all currently serviceable locations. Still dropping
 off informational packets/door knockers. Curtin asked the schedule for targeting service. Using
 yard signs to further notify the public it's in the area. Curtin would like a map to show where fiber
 is to easily answer inquiries of where and when fiber will be in a particular area.
- b) Main Street URD Project Update:
 - On hold. Town still working on selecting an engineer.
- c) 50 Main Street Garage Update:
 - Framing out and insulating.
- d) Leominster RMV EV Charger:
 - No change.

- e) Town of Sterling EV Charger Update:
 - Behind Town Hall is done and in database. Still working on Library.
- f) Fiber Marketing:
 - Putting still image on website, working with Futura for interactive map for member search for fiber availability.
- g) Rate Study Update:
 - Still In progress. Packet includes a presentation which includes rate comparison.
- h) LED FL Conversion:
 - Replaced 30 this year @ \$331/per \$9,930, capital to be depreciated.
- i) 2022 SMLD Draft 2 Budget Review:
 - There were a couple of clerical errors that have been corrected. Vote to approve the draft 2022 budget \$8,336,642, broken down at \$7,730, 407 for electric and \$606,235 for fiber. **Pierce made a motion to approve the 2022 draft budget**, Darlington seconded, no discussion, all in favor. Darlington aye, Curtin aye, Pierce aye.
