<u>ARTICLE 3.</u> Voted to transfer from stabilization the sum of \$650 to pay an outstanding fiscal year 2006 invoice.

9/10ths VOTE DECLARED BY MODERATOR

<u>ARTICLE 4</u>. Voted to amend Article 4 of the Special Town Meeting held November 13, 2006 by striking Map 98 Parcel 5 (5.1ac) and reducing the total acreage from 82.4 to 77.3 and changing the dollar amount of consideration from \$180,000 to \$171,000.

<u>ARTICLE 5</u>. Voted to transfer from the Stabilization Fund the sum of \$50,000 to establish an Insurance Recovery account for the Fire Department.

<u>ARTICLE 6.</u> Voted to transfer from an, the DPW Wage Account, a sum of \$19,054.00, to the Snow and Ice Account to cover the deficit in the snow and ice budget for the current fiscal year.
